

Our Method Partners are very important to us. As such, we've created the following agreement with you in mind to ensure a successful partnership where you are always treated fairly.

Please take the time to review in full. Don't hesitate to contact our Method Partner Team with any questions.

## Overview of Agreement

This overview is specific to the Method Partner Program and only part of the full [Terms and Service](#) and [Privacy Policy](#) for Method Integration Inc.

### **Commission:**

- 5% of subscription payments for first 6 months of referral for non-certified Partners.
- 10% of subscription payments for certified Partners on lifetime of referred accounts.

### **Method account discount:**

- 1 Method account with 2 free users for first 6 months for non-certified Partners. Certified Partners can extend the discount until their next recertification date.
- 2nd Method account with 2 free users for certified Partners (intended for demos).

### **Referral method:**

- Dedicated referral link.

### **Commission payment method:**

- Electronic bank transfer.

### **Payment delay:**

- Up to one month (e.g. January's commission paid by end of February)

### **Certification:**

- Required within 6 months of enrollment to maintain Method account discount.
- Required within 6 months of enrollment to receive 10% commission levels.
- Annual recertification required to maintain 10% commission levels and discounts.

## The Agreement

This agreement describes the terms and conditions for the Method Partner Program (hereafter referred to as "Partner Program").

"Partner" refers to you (the applicant) and "We" refers to Method Integration Inc.

## Modification

We may modify any of the terms and conditions within this Agreement at any time and at our sole discretion. This can include but is not limited to: referral rates, fee schedules, payment procedures and other Partner Program terms.

We will always do our best to notify you of any significant changes to the terms or conditions but cannot guarantee to do so for every modification.

In the event you find any modifications unacceptable to you, the only option will be terminate your involvement in our Partner Program. Otherwise, we assume your continued involvement.

## Enrollment

Participation in the Partner Program starts by application and submitting necessary details. Applicants will be notified of their acceptance status as soon the information is reviewed (usually within three business days).

## Making Referrals

You will be provided with one or more URLs ("Referral Links") which are specific to you and your company to be used to refer Method.

If a visitor (potential referral) uses/clicks your Referral Link and subsequently becomes a paying customer of Method, their account will be associated with your Partner account for commissions.

Referrals will only be tracked with your Partner account when using the dedicated Referral Link.

## Protecting You Referrals

It may be likely that a potential referral may sign up for Method from another source such as our direct sales site. For this reason, it is highly recommended you submit your prospect referrals from within your Partner Portal as soon as possible.

In the event your referral did not use your Referral Link when subscribing to Method, you may request a review to have us manually associate the referral with your Partner account.

Reviews will only be accepted

- For leads submitted within the Partner Portal on or before the client subscribes to Method.
- For leads up to 3 months from the client subscription date.

## Payments

Commissions are paid by electronic banks transfer. If your banking details change, it is your responsibility to update and notify us to ensure proper commission payment.

Commission payments are paid monthly for the prior calendar month. For example: January's earned commission will be paid by end of February. This delay is to ensure commissions are properly calculated and for any necessary manual adjustments.

## Certification

A Method certification test is provided as an additional option. Completing the certification is a requirement for:

- Discounts on your Method account(s).
- Upgrade to 10% commission levels for the lifetime of referred subscriptions.
- Note, we will require our certified Partners to recertify annually each July.
- Newly certified Partners will be due for first renewal on their next calendar year.

Partners who fail to pass or meet their certification deadlines will have their Method account discounts removed and be reduced to the lower tiered commissions structure of 5% for the first 6 months of account subscription referrals only.

Partners who recertify post deadline, will have their previous discounts and commission structure restored for subscriptions moving forward (no consideration for retroactive discounts or commissions).

## Discounted Method Account(s)

The discounted Method:CRM account(s) provided to you with your participation in the Partner Program are intended for your personal company use and/or demo and learning purpose only. These accounts are not for resale.

The discounts provided (see below) are dependent on (a) your active status in our Partner Program, (b) maintaining the required certification(s), and finally (c) ensuring you provide payment details for the account.

- 1 Method account with 2 free users for first 6 months for non-certified Partners. Discount to be extended for Partners who certify.
- 2nd Method account with 2 free users for certified Partners.

Partners who do not meet these requirements will have the discounts removed and have the option to pay in full or cancel the accounts. Note, when you cancel your account, all CRM data and customizations associated with that account is erased.

## Offering Your Value Added Services

Customers who subscribe to Method by Partner referral will be deemed customers of Method Integration. These customers will also adhere to our full [Terms and Service](#) and [Privacy Policy](#) for Method Integration Inc.

Partners may choose to offer value added services to Method's customers where appropriate.

## Terms and Termination

The terms of this agreement will begin when your application is accepted and will end when terminated by you or by Method. You will still be eligible for commissions earned before the termination date.

Method reserves the right to terminate your participation in the Partner Program at any time, without notice, for any reason.

## Relationship

As a Partner, you are an independent contractor, and nothing in this agreement will create any other type of partnership. Partners have no authority to make or accept any offers or representations on our behalf. Partners will not make any statement, whether on their sites or otherwise, that reasonably would contradict this statement.

## Limitations

Method will not be liable for indirect, special, or consequential damages (or any loss of revenue, profits, expenditures or data) arising in connection with your participation in the Partner Program.

We make no express or implied warranties or representations with respect to the Partner Program or a Partner's potential to earn income from the Partner Program.

In addition, we make no representation that the operation of the websites, product, or referral links will be uninterrupted or error-free, and Method Integration will not be liable for the consequences of any interruptions or errors.
